# The Criminal Procedure Code (Offences Prescribed Under Section 221) Notice, 1986

- 2. The offences set out in the Schedule hereto are hereby prescribed as offences to which the provisions of section two hundred and twenty-one of the Criminal Procedure Code shall apply.
- 3. The Notice specifying offences to which section 199A of the Criminal Procedure Code shall apply is hereby revoked.

## SCHEDULE (Paragraph 2)

OFFENDES TO WHICH THE PROVISIONS OF SECTION 221 OF THE CRIMINAL PROCEDURE CODE SHALL APPLY

#### Offences-

- (g) against the provisions of the Rules of the Road Regulations in respect of which no penalty is provided other than by regulation 19 of the said Regulations;
- (h) against the provisions of the Roads and Road Truffic (Bus and Taxicab Drivers Uniform) Regulation, 1982, in respect of which no penalty is provided other than by regulation 5 of the said Regulations;
- (i) created by sections 7 (1) and 14 (1) (a), (b) and (c) of the Broadcasting Act;
- (j) oreated by section 82 (1) (\*) (iii) of the Posts and Telecommunications Corporation Act.

# The Extradition (Declared Commonwealth Countries) Order, 1986

IN EXERCISE of the powers contained in section sixteen of the Extradition Act, the following Order is hereby made:
