STATUTORY INSTRUMENT NO. 38 OF 2008

The Road Traffic Act
(Act No. 11 of 2002)

The Road Traffic (Fees) Regulations, 2008

IN EXERCISE of the powers contained in section *two hundred and thirty-three* of the Road Traffic Act, 2002, and on the advice of the Agency, the following Regulations are hereby made:

1. (1) These Regulations may be cited as the Road Traffic (Fees) Regulations, 2008. Title and Commencement
- (2) These Regulations shall come into effect on the expiration of a period of thirty days after the date on which they are published in the *Gazette*.
2. The fees set out in the Schedule to these Regulations shall be payable for the licences, certificates and other matters specified therein. Prescribed fees
3. For the avoidance of doubt, any fees prescribed by any other Regulations for the licences, certificates and other matters specified in the Schedule to these Regulations shall cease to have effect from the commencement of these Regulations. Fees under other Regulations to cease to apply
