An Act to amend the Mines and Minerals Act

[18th April, 1997

ENACTED by the Parliament of Zambia.

1. (1) This Actmay be cited as the Minesand Minerals (Amendment) Act, 1997, and shall be read as one with the Mines and Minerals Act, in this Act referred to as the-principal Act.

(2) This Act shall come into operation on the 1st April, 1997.

The principal Act is amended by the insertion immediately 2. after section sixty-six of the following new sections:

> The Zambia Revenue Authority established under 66A. the Zambia Revenue Authority Act, shall be responsible for responsible for carrying out the provisions of sections sixty-six to sixty-nine of 321 this Act.

66B. Sections forty-five, forty-seven to forty-nine, fifty- Returns and five to fifty-eight, sixty-three to seventy, seventy-eight, seventy-nine, eighty-seven, ninety-one, ninety-five and ninetyeight to one hundred and fifteen of the Income Tax Act shall, Cap. 323 with the necessary modification, apply to the collection, assessment, penalisation, enforcement of, and right of appeal with respect to any royalty imposed under section sixty-six of this Act.
