### **The Fisheries Act** (Act No. 22 of 2011)

#### **The Fisheries (Fisheries Prohibition) Notice, 2018**

IT IS NOTIFIED for public information in exercise of section 14 of the Fisheries Act, No. 22 of 2011, that the 2018/2019 annual fishing ban will be in effect from 1st December, 2018 to 28th February, 2019. All Kinds of fishing activities are prohibited on the following fisheries: Lake Mweru Luapula, Lake Bangweulu, Lake Mweru - wa - ntipa, Kafue flood plain, lower upper and supper upper Kafue River, Chambeshi River, upper and supper upper Zambezi River, Lake Itzhi-tezhi, Lunga River, Lukanga Swamps, Lusiwashu Dam and Lower Zambezi River.

The public is further informed that Lakes Kariba and Tanganyika will not be affected by the fishing ban. Members of the public that wish to transport fish products from these areas are advised to ensure that they obtain certificates of origin of fish from the nearest Department of Fisheries offices prior to transporting any fish products. Likewise fish farming activities will continue and all those trading or transporting fish products from fish farms should have valid certificates of origin of fish issued by the Department of Fisheries.

Any person that contravenes the provisions of this notice commits an offence and is liable, upon conviction to a fine not exceeding two hundred thousand penalty units or to imprisonment for a period not exceeding two years, or to both.
