Foot-and-Mouth Disease (FMD) Outbreaks in Mazabuka, Pemba, Namwala, Gwembe, Chilanga, Kapiri Mposhi, Mumbwa, Kabwe, Choma, Chingola, Chipata, Vubwi and Lundazi Districts

IN ACCORDANCE with the provisions of Sections 12, 22, and 23 of the Animal Health Act No. 27 of 2010 of the Laws of Zambia, it is hereby notified for the information of the public in general and the farming community in particular that there is an outbreak of foot and Mouth Disease (FMD) in Mazabuka, Pemba, Namwala, Gwembe, Chilanga, Kapiri Mposhi, Mumbwa, Kabwe, Choma, Chingola, Chipata, Vubwi and Lundazi Districts.

Foot-and-Mouth Disease (FMD) is a highly infectious and devastating transboundary viral disease of cloven hoofed animals that impedes trade in animal and animal commodities. It is a notifiable disease whose occurrence has to be reported to the nearest veterinary office.

In view of these outbreaks, the Ministry of Fisheries and Livestock has with immediate effect instituted the following measures:

1. Banned the slaughter of cattle, pigs, goats and sheep at abattoirs within the aforementioned districts until the following measures are put in place:
 - (a) Ante and post mortem inspections to be done under Department of Veterinary Services supervision at abattoirs and slaughter slabs.
 - (b) Cure of Meat for 48 hours to ensure that the pH drops to 6 or less.
 - (c) Improvement in biosecurity of the farms by putting up a wheel bath for disinfection at the entrance of all strategic facilities.
2. Banned the movements of all cloven hoofed animals such as cattle, pigs, goats, sheep and their products into and out of the aforementioned districts.
3. Banned the sale of raw milk within a radius of 15kms from the infected farms. All raw milk must be pasteurised, including that used for feeding calves according to protocol.
4. Intensified surveillance and inspections of farms to ascertain the presence or absence of the disease.
5. Establishment of bio-security check points at strategic points.
6. Vaccination of cattle in the affected areas with the specific vaccine serotype.
7. Any other measures that may be introduced.

These measures are intended to prevent the spread of this disease to other areas of the country. It is therefore an offence not to comply with the measures put in place.

The general public is hereby requested to be vigilant and report cattle, pigs, goats and sheep showing the following signs to the nearest veterinary office:

- Drooling of saliva from the mouth
- Lameness
- Failing to eat
- Drop in milk production
- Sores in the mouth, around the mouth and on the hooves

All farmers, traders and the general public are requested to cooperate with veterinary officials in controlling this disease and prevent further spread.

Farmers in general are further advised to:

1. Source breeding stock, feed and semen from reputable suppliers with assured Foot-and-Mouth Disease freedom
2. Increase bio-security and limit visitors on their farms
