**Purchase of Designated Commodities During the 2020/21 Crop Marketing Season**

PURSUANT to Section 7 (2) (3) of the Food Reserve Act, Cap. 225 of the Laws of Zambia, the Food Reserve Agency hereby announces its plan for purchases of designated agriculture commodities during the year 2020/21 Marketing Season. This year's Crop Marketing exercise will commence on the 1st of June, 2020 and will close on the 31st of October, 2020 Subject to market dynamics.

**Commodities to be purchased**

—Maize, Paddy rice and Soya beans

**Quantities to be purchased;**

—Maize—Minimum of 150,000 metric tons

—Paddy rice—Minimum of 1,000 metric tons

—Soya beans—Minimum of 3,000 metric tons

**Purchase location;**

—At least 400 satellite depots shall be opened in 105 districts

**Method of purchased;**

—Farmers shall deliver their crops to designated satellite depots which will be operated by FRA representatives as buying agents;

—Farmers shall be issued with Produce Received and Certification Notes (PRCN) at the satellite depot;

—FRA representatives shall inspect the crop for quality and quantity and then issue appropriate documentation evidencing the transaction; and

—Crop deliveries shall be confirmed by FRA representative at main holding depots who shall then process farmer's payments.

**Method of payment;**

—The farmers shall present the Produce Received and Certification Note or its equivalent and their National Registration Cards to a designated paying local Bank or Financial Institution in order to receive payment;

—The FRA may consider alternative payment methods that may be convenient for farmers that will supply crops if such need should arise.
