In order to determine if any member of the public is in possession of tyres subject to the recall (and therefore, eligible for a free replacement), affected members of the public will need to locate the DOT Tyre ID which is located on the sidewall of the tyres.

The affected tyres may lead to a crash. Bulges or separations in the sidewall area of the tyre may develop that, if undetected, may result in a loss of inflation pressure and potential tyre failure leading to the loss of vehicle control. Some affected tyres may display a visual anomaly on the white steering or ride. Driving at high speed should be avoided until the tyre have been inspected and replaced, if they fall within the DOT Tyre IDs.
