The Value Added Tax (General) (Amendment) Rules, 2022

IN EXERCISE of powers contained in sections *ten, eleven, twelve, thirteen, eighteen, twenty-seven, twenty-eight, fifty-two and fifty-three* of the Value Added Tax Act, the following Rules are hereby made:

Title Gazette Notice No. 310 of 2020

(1) These Rules may be cited as the Value Added Tax (General) (Amendment) Rules, 2022 and shall be read as one with the Value Added Tax (General) Rules, 2020 in these Rules referred to as the principal Rules.

Amendment of Third Schedule

The Third Schedule to the principal Rules is amended by the deletion of the item listed in the Table set out in Appendix I to these Rules and the addition of the item listed in the Table set out in the Appendix II to these Rules.
