Relaxation of the ban on movement of pigs and pig products into and out of Lusaka Province that was imposed due to an outbreak African Swine Fever

It is for the information of the general public, purveyors of live-stock and farming community in particular that the measures that were promulgated in Gazette notice No.517 of 2022 to control ASF outbreak in Lusaka Province have been relaxed.

The following measures shall be in force from 5th May, 2022 subject to review after ninety days:

1. Only live pigs originating from farms that have Animal Identification Mark(s) issued under the Animal Identification Act shall be allowed to move subject to production of an abattoir assurance and negative laboratory ASF test results;

2. Only pig carcasses or pork products slaughtered or processed at registered facilities will be allowed to move within or out of the province;

3. Only pig sale yards, slaughter facilities or processing plants that are registered under the Animal Health Act shall be allowed to operate;

4. Live pigs, pig carcasses or pork products will only be allowed to transit from any part of Zambia to another part of Zambia through Lusaka Province under strict conditions stipulated by the Department of Veterinary Services;

Veterinary Officers shall take any other such measures as deemed necessary for the control of the disease;

Any person found contravening the measures outlined in the notice shall be prosecuted and appropriate penalties shall apply.

Pigs, pig carcasses or pork products, conveyances and premises that shall be the subject of such contravention shall be destroyed without compensation (in case of pigs, pig carcasses or pork products) or forfeited to the state (in case of conveyances) or subjected to appropriate provisions in the Act or as court may direct (in case of building);
