In pursuance of the detailed winding up of the Estate of the said Deceased, an indepth 'Traditional Enquiry' into the domicile of origin of the Deceased was conducted by the Administratrix and the Head Priest of the Late Otumfuo Badu Bonsu II, in the Tano Yaw Shrine in Ejisu Besease, and in the Ahanta Kingdom in the Western Region of Ghana. It was found that the deceased was born in 1835, in the Ahanta Royal Palace in Oluwosuwua of the late Otumfuo Badu Bonsu II, King of the West African Gold Coast. That She was taken out of the fire with a Black and Golden Queen Stool when the Palace was burnt down in 1838, as a hostage Princess in Ejisu Besease Tano Yaw, in the Asante Kingdom. She became the first Ejisu Queen Regent in 1896, and the first Female Asantehene of the Dominion of the Akan Asante Confederacy in November 1895, and died on the 17th day of October, 1921 as a Prisoner of War on the British Crown Colony of the Seychelles in Le Rocher Mahe.

That the Administratrix of Her Estate hereby requires all unauthorised Asset holders in Commonwealth and United Nations Member States including the KwaZulu Natal Museum and other Museums, Regiments, Royal Collections, Private Estates, Auction Houses etc, who have possession and/or unauthorised use, of any surviving Assets belonging and pertaining to the Estate of the above named Deceased, after they were misappropriated, looted and redistributed during the Ahanta-Dutch-Asante Punitive Mission of 1838, and during the 3rd, 4th, 5th Anglo Ashanti Wars from 1838-1901: should provide by email to the Administratrix as undersigned, a detailed inventory regarding the Assets in their possession; and allocate a date when delivery up of these Assets will be made to the Estate, within 3 calendar months of the date of this publication.
