**The Electoral Process (Local Government Elections)
(Election Dates and Times of Poll) Order, 2016**

IN EXERCISE of the powers contained in sections 26 and 28 of the Electoral Process Act, 2016, the following Order is made:

Title

1. This Order may be cited as the Electoral Process (Local Government elections) (Election Dates and Times of Poll) Order, 2016.

2. Nominations for the election of a council chairperson and councilor in the districts and wards set out in the Schedule may be lodged with the returning officer on Thursday, 20th October, 2016, between 0900 hours and 1500 hours.

3. The campaign period shall commence on Thursday, 20th October, 2016, at 1500 hours and close at 1800 hours on Wednesday, 16th November, 2016.

4. The poll for the election of a council chairperson and councilor in the districts and wards set out in the Schedule shall be taken on Thursday, 17th November, 2016, between 0600 hours and 1800 hours, except that a poll shall not be taken in a district or ward in which only one candidate is validly nominated.
