(1) A person shall not load or offload any commercial goods from a motor vehicle or park a motor vehicle of gross weight exceeding of three thousand five hundred kilograms on a road in Kabwe municipality set out in the First Schedule between the hours specified in the Second Schedule.</p> | <p>Prohibition of loading, offloading or parking</p> |
| <p>(2) A person who contravenes sub-regulation (1) commits an offence and is liable, upon conviction, to a fine not exceeding one thousand penalty units or to imprisonment for a term not exceeding three months, or to both.</p>                                                                      |                                                      |

## PROHIBITED ROADS

That part of—

- (a) Freedom Way which lies between its junction with Pauling Street and its junction with Mulungushi Street;
- (b) Independence Way which lies between Pauling Street and Marshall Avenue;
- (c) Katebo Chilufya Street which lies between Munkoya Street and Marshall Avenue;
- (d) Buntungwa Street which lies between Mumba Crescent and Marshall Mall;
- (e) Lubuto Street which lies between Freedom Way and Marshall Avenue;
- (f) Great North Road which lies between its junction with Independence Way and Freedom Way and its junction with Luapula street.
- (g) Machile Street which lies between Freedom Way and Marshall Avenue; and
- (h) Mulungushi Street which lies between Independence Way and Marshall Avenue.
